

FAIR CREDIT REPORTING ACT DISCLOSURE AND AUTHORIZATION

DISCLOSURE

As an applicant for a coaching position with Southeast Denver Baseball, Inc. d/b/a Southeast Denver Baseball & Softball League (“SEDBSL”), you are or may be a consumer with rights under the Fair Credit Reporting Act. When any of the following circumstances exist, SEDBSL may choose to obtain and use information contained in either a consumer report or an investigative consumer report from a consumer reporting agency about you: (1) when considering your application for a coaching position, (2) when making a decision whether to offer you such a position, or (3) when deciding whether to continue such a position, if offered.

A “consumer reporting agency” is a person or business which, for monetary fees, dues, or on a cooperative nonprofit basis, regularly assembles or evaluates consumer credit information or other information on consumers for the purpose of furnishing consumer reports to others, such as SEDBSL.

A “consumer report” means any written, oral, or other communication of any information by a consumer reporting agency bearing on your credit worthiness, credit standing, credit capacity, character, general reputation, personal characteristics, or mode of living which is used or expected to be used or collected in whole or in part for the purpose of serving as a factor in establishing your eligibility for employment.

An “investigative consumer report” means a consumer report or portion thereof in which information on your character, general reputation, personal characteristics, or mode of living is obtained through personal interviews with your neighbors, friends, or associates reported on or with others with whom you are acquainted or who may have knowledge concerning any such items of information.

SEDBSL may request an investigative consumer report. You may request, in writing and within a reasonable time, additional disclosures regarding the nature and scope of the investigation, which SEDBSL will limit to the law enforcement agencies and courts references in the Background Check.

AUTHORIZATION

By signing below, I, _____, hereby voluntarily authorize SEDBSL to obtain either a consumer report or an investigative consumer report about me, as set forth in the attached Background Check, from a consumer reporting agency and to consider this information when making decisions regarding my position with SEDBSL. I understand that I have rights under the Fair Credit Reporting Act, including the rights discussed above.
